Notes to Form of Proxy

- 1. Terms defined in the Company's scheme circular dated 29 March 2022 (the "Scheme Document") shall apply equally in this Form of Proxy, unless the context otherwise requires. All times referred to in this Form of Proxy are in London time unless otherwise stated. You are advised to read the Scheme Document in full. It is available at www.mckaysecurities.plc.uk. Full details of the resolution to be proposed at the Court Meeting, together with explanatory notes, are set out in the Notice of Court Meeting at Part X of the Scheme Document. Before completing this Form of Proxy, please also read the sections entitled "Action to be Taken" set out on pages 10 to 13 of the Scheme Document.
- 2. The Court has appointed Richard Grainger or, failing him, Simon Perkins or, failing him, any other McKay Director to act as Chair of the Court Meeting and has directed the Chair to report the result thereof to the Court.
- 3. Only Scheme Shareholders, or their duly appointed proxies or corporate representatives, are entitled to attend and vote at the Court Meeting. Each Scheme Shareholder has the right to appoint some other person(s) of their choice, who need not be a shareholder of the Company, as their proxy to exercise all or any of their rights to attend, submit questions and/or objections and to vote on their behalf at the Court Meeting. Scheme Shareholders are strongly encouraged to submit proxy appointments and instructions for the Court Meeting as soon as possible, using any of the methods (by post, online or electronically through CREST) set out below. Scheme Shareholders are also strongly encouraged to appoint "the Chair of the Court Meeting" as their proxy. - 15. This Form of Proxy must be signed and dated by the shareholder or his/her attorney duly authorised in writing. If the shareholder is a company, it may execute this proxy by the signature(s) of a duly authorised officer or attorney of the Company whose capacity should be stated. Any power of attorney or other authority under which this Form of Proxy is signed (or a duly certified copy thereof) must be returned to the Registrars with this Form of Proxy. In the case of joint holders of Scheme Shares, any one holder may sign this Form of Proxy. The vote of the senior joint holder who tenders a vote, whether in person or by proxy, will be accepted to the exclusion of the votes of the other joint holders and for this purpose seniority will be determined by the order in which the names stand in the register of members of the Company in respect of the joint holding. If you submit more than one valid proxy appointment, the appointment received last before the latest time for the receipt of proxies will take precedence.
- 16. As an alternative to appointing a proxy, any holder of Scheme Shares which is a corporation may appoint one or more corporate representatives who may exercise on its behalf all its powers as a member, provided that if two or more corporate representatives purport to vote in respect of the same shares, if they purport to exercise the power in the same way as each other, the power is treated as exercised in that way, and in other cases the power is treated as not exercised.
